





- Once you have logged into WIN, click on the Airfreight tab to access your Airfreight Dashboard




 You may also create bookings from WIN Flight Schedules search results




- Fill in the details of your booking and click save; only fields with red asterisks (*) are mandatory
- Once a booking has been saved, you have the option to discard, duplicate, edit or send it






Once the booking has been sent to the airline, you can track its statuses and/or jump into creating AWBs
